

LOCAL LAW 4 OF 2019

A LOCAL AMENDING CHAPTER 291 OF THE CODE OF THE VILLAGE OF WALDEN ENTITLED “VEHICLES AND TRAFFIC” TO THE EXTENT OF AMENDING SECTION 291-17 RELATIVE TO THE LIMITED TIME PARKING ON MAIN STREET AND WEST MAIN STREET

BE IT ENACTED by the Village Board of the Village of Walden as follows:

SECTION 1 - TITLE

This Local Law shall be referred to as “A Local Law Amending Chapter 291 of the Code of the Village of Walden entitled “Vehicle and Traffic” to the extent of amending Section 291-17 relative to the limited time parking on Main Street and West Main Street.”

SECTION 2 – PURPOSE & INTENT

The purpose of this Local Law is to ensure that adequate public parking is facilitated throughout the Village so as to accommodate the need of both clients and customers of commercial enterprises as well as residential inhabitants and to facilitate proper vehicular and traffic management.

SECTION 3 – AMENDMENT TO TEXT OF CODE SECTION 291-17. Existing Code Section 291-17 is hereby repealed and replaced with the following:

SECTION 4 - VALIDITY

If any clause, sentence, paragraph, word, section or part of this local law shall be adjudged by any court of competent jurisdiction to be unconstitutional, illegal or invalid, such judgment shall not affect, impair or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, word, section or part thereof directly involved in the controversy in which such judgment shall have been rendered.

SECTION 5- EFFECTIVE DATE

This Local Law shall take effect immediately when it is filed in the Office of the New York State Secretary of State in accordance with Section 27 of the Municipal Home Rule Law.
