

Village of Walden Community Green House Gas Inventory

Climate Smart Communities Program

January 2021

Naturally occurring gases dispersed in the atmosphere determine the Earth's climate by trapping solar radiation. This phenomenon is known as the greenhouse effect. Overwhelming evidence shows that human activities are increasing the concentration of greenhouse gases and changing the global climate. The most significant contributor is the burning of fossil fuels for transportation, electricity generation and other purposes, which introduces large amounts of carbon dioxide and other greenhouse gases into the atmosphere. Generally, greenhouse gases include carbon dioxide (CO₂), methane (CH₄), and nitrous oxide (N₂O), as well as hydrofluorocarbons (HFCs), Perfluorocarbons (PFC), and Sulfur hexafluoride (SF₆). Together, these six internationally recognized greenhouse gases accounted for 99.6 percent of national greenhouse gas emissions in 2010¹. Collectively, these gases intensify the natural greenhouse effect, causing global average surface and lower atmospheric temperatures to rise. To respond to the climate emergency, New York State passed the Climate Leadership and Community Protection Act (The Climate Act) in June 2019.

The Village of Walden, through their participation in the Climate Smart Community Program, recognizes that that greenhouse gas (GHG) emissions from human activity are catalyzing profound climate change, the consequences of which pose substantial risks to the future health, wellbeing, and prosperity of our community. Furthermore, the Village has multiple opportunities to benefit by acting quickly to reduce community GHG emissions.

The Mid-Hudson Regional Greenhouse Gas Emissions Inventory (2012) is based upon GHG readings taken by New York State in 2010 indicates that the region's total emissions across all sectors in 2010 were approximately 26.5 million MTCO_{2e}². The single largest source of GHG emissions is the energy consumption for transportation, which is responsible for 45 percent of regional emissions or 11.9 million MTCO_{2e}.

Leading emission sources are consistent at the local level as well with transportation leading the way. Local GHG emissions levels are reported in the Mid-Hudson Inventory as follows:

- **Village of Walden: 83,551 MTCO_{2e}**
- **Town of Montgomery: 269,844 MTCO_{2e}**
- **Orange County: 4,382,339 MTCO_{2e}**

While the Village Walden’s emissions are more than double surrounding Village’s such as the Village of Maybrook and the Village of Montgomery when totals are evaluated on a per capita basis emissions totals are similar (see table below).
